In the Memo under reference cited, certain instructions were issued that the Chairman/TANTRANSCO has approved for implementation of Centralized payment in respect of Suppliers Contractors, Revenue expenses and other bills with effect from 20.05.2024. Accordingly, instructions were issued to bill passing officials of TANTRANSCO at circles and Headquarters for Centralized payment system. It was also instructed that the manual interventions is minimized, the accuracy of the details on SAP – ERP has to be ensured by the bill processing and passing authorities concerned.

- 2. The staff bills are passed through ERP. Since all the employees are mapped under TAMIL NADU POWER DISTRIBUTION CORPORATION LIMITED (TNPDCL) company code, the same is not reflected in TANTRANSCO fund indent. Hence, the payment is made by allotting funds to the circles in respect of all the circles including General Construction Circles/Protection and Communications and State Load Dispatch Centers.
- 3. While analyzing the above facts and to streamline bills payments related to employees and to avoid duplication in payments, the Joint Managing Director/Finance TANTRANSCO has directed to verify the passed bills relating to TANTRANSCO before allotting funds, in T-code "ZFIVPR" in the profit centre (2103) and he has also directed that the staff bills relating to TANTRANSCO passed in ERP will be listed in a separate profit centre for TANTRANSCO (2103).
- 4. The above decision has been examined in detail. Accordingly, it is hereby ordered that all the Superintending Engineers / General Constructions Circles/Protections and Communications Circles and Electricity Distributions Circles (for Operation circles), State Load Dispatch Centers and Non Conventional Energy Sources circles to instruct the officials and staff concerned to indicate the ERP Document Nos for staff Payment and other bills passed through ERP in the monthly indent with effect from 01.09.2024.
