- 2. Meanwhile, the circle officials have raised various concerns in payment of the aforesaid categories of payment through 'Centralised Payment System', as detailed below:

SI. No.	Payment Category	Difficulties faced in the centralised payment system
1	CPRI (Central Power Research Institute) Testing	To be paid through online.
2	Telephone Bill	For One Vendor numerous Vendor ID and Bank A/c-s and last minute payment causes 'telephone line disconnection'.
3	Any Online Payment	Not feasible to pay through ERP. Can be paid only from the concerned Circle.
4	Conveyance Advance & Computer Advance	
5	Court Attachment & Govt. Land Acquisition payment	To be paid as 'Cheque/DD' by the concerned circle.

- 3. These causes have been discussed in detail in the meeting held by JMD, as referred above, and it has been decided to de-centralise the above categories of payment. The Superintending Engineers and Financial Controllers of the circle are hereby directed to instruct their concerned officials to pay CPRI (Central Power Research Institute) Testing Fees, Telephone Bill, Any Online Payment, Conveyance Advance, Computer Advance, Court Attachment & Govt. Land Acquisition payment from the concerned Circle, through 'Head Quarters Fund Allotment' method. This instruction shall be carried out with immediate effect. The fund for the said categories of payment will be allotted to the concerned circle by the 'DFC/Funds/Headquarters'.
- 4. The circle officials concerned, are hereby instructed not to utilize the fund allotted for the aforesaid categories of payment for any other purpose, failing which suitable action may be initiated against the erring official as deemed fit.
