PROCEEDINGS:-

In the Government order first read above, orders were issued bifurcating the Tamil Nadu Generation and Distribution Corporation Ltd into separate generation and distribution Companies, viz. Tamil Nadu Power Generation Corporation Ltd (TNPGL) and Tamil Nadu Power Distribution Corporation Ltd (TNPDC). The TNPGL to take care of the fossil fuel (coal and gas) related existing plants with the functions of operation of existing assets, monitoring of under constructions power plants, fuel procurement and management, Renovation & Modernization, Emission Control and Compliance, maintenance and safety, Resource Management, Regulatory Compliance and Co-ordination with State Transco and Discom on power supply matter, development of infrastructure.

2. In the Government order second read above, orders were issued for the formation of TNGECL under Companies Act 2013, by integrating Renewable Energy wing of TANGEDCO and merger of TEDA with the new Green Energy Company.

3. In the Government order third read above, orders were issued to makes the terms and conditions of the schemes for defining the property, interest in property, rights and liabilities of the TANGEDCO to be allocated to the TNPGL and TNGECL and also for the transfer of officers and employees of TANGEDCO to the TNPGL and TNGECL.
