In the Board's Proceedings first read above, the erstwhile TANGEDCO had constituted a Committee to negotiate with the Unions/Associations on revision of pay matrix, work allocation and staff pattern to take effect from 1-12-2019.

- 2. In the Board's Proceedings second read above, the erstwhile TANGEDCO had constituted Sub-Committees to suggest suitable revised work norms in respect of areas, which have already been covered by Work Load settlements.
- 3. In pursuance of the settlement made with Trade Unions/Associations on 16.05.2023, orders have been issued for Revision of Wages/Pay to the Employees/Officers vide in the references 4th and 5th cited. In that settlement, it has been agreed to finalize the Work Allocation and staff pattern within three months. Accordingly, the Work Load Sub-Committees have submitted their reports for the above said Work Load areas and same was not yet finalized.
- 4. In the meantime, the period of the existing Wage Revision settlement expired on 30.11.2023 and the next Wage Revision is due from 01.12.2023. Accordingly, the TNPDCL had constituted a Committee to negotiate with the Unions for revision of pay, Work allocation and staff pattern to be effective from 01.12.2023 for Class III and IV Employees vide in the reference 6th cited.

5. In view of the discontinuance and redeployment of certain posts and introduction of digitalization in ERP, GIS, LT and HT etc., in the Work Load areas, it has been suggested to include the suitable members in the Work Load Sub-Committee. Accordingly, the following four Sub-Committees be reconstituted and the Officers mentioned in each committee are nominated as Members of the Sub-Committees to suggest suitable revised workload norms and to submit a report for the Revision of Work Allocation and Staff Pattern effective from 1.12.2023:-
