Sub: TANTRANSCO – Accounts Branch – Dispensing of Operation Circles mapped to General Construction Circle - Operation Circle bill passing and payment in the Existing Electricity Distribution Circles – Instruction – Issued.

The attention of all the Superintending Engineers of General Construction Circle may be invited to the references cited. The Operation Circles have been mapped with the General Construction Circle for the purpose of bill passing and payment. The bill passing and payment of Operation Circle has been taken up by the Superintending Engineer/General Construction Circle's with effect from the date of issue of this order (i.e.06.01.2025). Subsequently, based on the request made by all the Deputy Financial Controller/ General Construction Circles and the request made by the Director Operation/TANTRANSCO the time limit has been extended upto 31.03.2025 in the reference 3<sup>rd</sup> & 4<sup>th</sup> cited.

2. Now, the Union's have made representation to the Chairman cum Managing Director that the Funds and bills for the operation wing is being handled by TNPDCL/TANGEDCO so far. In order to streamlining the system, it has been decided to entrust the Funds and bills pertaining to operation wing to GCC wings and orders has been passed in this regard. The Joint Managing Director /Finance has also agreed and stalled this new procedure until this month end on 31.03.2025. Hence, they have requested to put the decision on hold further beyond 31.03.2025 and not to implement the decision until discussing with Unions.

3. Therefore all the Superintending Engineers/General Construction circles / Operation circles / Electricity Distribution circles are instructed that the bill passing of Operation circle and payment shall be continued in the Electricity Distribution circles for the time being. The pilot study of Operation circle Madurai and South II taken up in the Headquarters will be dispensed and all the bills and the payments shall be made in the existing Electricity Distribution Circles until further orders.
