Sub: Estt – Class II Service – Assistant Engineer/Electrical selected by Internal Selction – Allotment Orders Issued.

In continuation of the above reference 5th cited, 06 Nos of employees from various cadres are provisionally selected and appointment to the post of Assistant Engineer/Electrical by through Internal Selection and fixing of pay Band of Rs.39800-126500 in Class II Service and allotment orders issued to various circle as furnished in the Annexure..

2) Their selection for appointment as Assistant Engineer/Electrical through Internal Selection is subject to the following conditions:-

- i) That their pay will be fixed by grant of personal pay to the extent of the difference in the basic pay admissible to them from time to time in the post of Assistant Engineer/ Electrical till it becomes equal to or more then the basic pay in the previous post of his promotion to higher post whichever is earlier, as per orders in B.P. Ms. (FB) No.95 (Sectt.Branch) dated 20.11.1985 and clarificatory orders issued thereon from time to time.
- ii) Since the appointment now ordered is by Internal Selection, the individuals are not eligible for fixation of pay under Regulation 33(b) of Tamil Nadu Electricity Board Service Regulation.
- iii) They should produce satisfactory evidence in original regarding their educational qualification, Date of birth and community before joining duty for verification and that if any discrepancy is found in the certificates or if they are found to be unqualified, their appointment will be cancelled immediately followed by cancellation of selection also.

- iv) As they have already furnished an undertaking relinquishing their rights for further promotion in their present cadre, in the event of their appointment as Assistant Engineer/Electrical they have no claim for further promotion in the present cadre.
- v) They will not be eligible for reversion to their parent cadre of post under any circumstances.
- vi) The appointment order shall be issued to the selected employees only after receipt of the genuineness Certificate.
- vii) The anomalies if any will not be considered.

3) The selected employees mentioned in the annexure for the post of Assistant Engineer/Electrical/ Mechanical/Civil is based on the date of cancellation of the proceedings No.47 dated 19.02.2018 and it may be stated that, their selection is considered sympathetically as a special case and they will not be eligible for requesting seniority in between the already selected candidate who were selected on merits as per the call letter. Further the eligible 06 individuals may be requested to furnish an undertaking that they will withdraw their cases and will not claim seniority, back wages etc..to avoid further litigations vide reference 5th cited.

4) An undertaking to the effect of items (i) to (vii) under para-2 above may be obtained from the individuals (in duplicate) before their joining as Assistant Engineer/Electrical. One copy of the undertaking should be pasted in Service Roll/Service Book of the individual and another copy should be retained in the Office of the Superintending Engineer.

5) The Superintending Engineers concerned are requested to issue orders of appointment on temporary basis under Regulation 106 of Tamil Nadu Electricity Board Service Regulation and postings subject to their agreeing to the above conditions in writing to the employees immediately.

6) Necessary form of Physical Fitness Certificate are enclosed and the individual may be directed to produce the Physical Fitness Certificate obtained from a Medical Officer not lower in rank than that of a Civil Surgeon to the Superintending Engineers concerned at the time of joining duty as Assistant Engineer/Electrical. If their vision are not normal then they have to produce a special certificate obtained from an Eye Specialist employed in a Govt. Hospital, furnishing the particulars mentioned in the annexure to the form of Physical Fitness Certificate. The Physical Fitness Certificate may be verified at your end.

7) The selected Candidates may be informed that they should join duty within one week from the date of relief in the present post, failing which it will be taken that they are not interested to accept the appointment and further action will be taken to cancel their appointment.

8) No representation for change of postings of extension of time limit to join duty will be entertained under any circumstances. Even if any attempt is made for modification through third person, the selection and appointment order will be cancelled.

9) The selected candidates may be informed that this selection is subject to the outcome of the Writ Petitions/Writ Appeal filed in this regard before the Hon'ble Madras High Court and its Madurai bench.

10) The Superintending Engineers concerned are requested to inform that the employees appointed to any post in TANGEDCO/ TANTRANSCO by Internal Selection are eligible to apply for request transfer within and beyond the circle after completion of one year service in the appointed station as per orders issued in (Per.) (CMD) TANGEDCO Proceedings No.72 (Adm. Branch) dated 23.11.2021.

11) The Superintending Engineers concerned are requested that to inform that to verify that the selected employees possess adequate knowledge in the Tamil language as specified in proceedings No.42 dated 28.November 2019 and also to verify for any disciplinary proceedings pending/Issued /ordered against the selected employee and if any is found, the selected employee may not be permitted to join duty and allotment order need not served, the fact report to the Head Quarters immediately.

12) The Superintending Engineers concerned are requested that the selected incumbents mentioned in the Annexure who were transferred/Promoted to some other circle, the orders may be forwarded to that circle and the fact may be intimated to this office and report the date of relief and date of joining of the individual promptly.

13) The Superintending Engineers concerned are requested to inform that the selected employees in the Annexure herewith as per rule of reservation only. The SPO/Recruitment stated that the seniority of the individuals may be arrived will be later and communicated and based on the clarification to be furnished by the Government that has been requested by the SPO/Recruitment, Adm.Branch in this regard.
