The individuals who have been provisionally selected for appointment as Assistant Engineer/Mechanical in the pay Band of Rs.39800-126500 in Class II Service through Internal Selection furnished in the Annexure are allotted to the Superintending Engineer's as indicated, and that the list of selected candidates is as per rule of reservation only. The Seniority of the individuals will be arrived and issued later based on the Clarification to be furnished by the Government.

2) It is informed that based on the approval accorded by the CMD TNPDC and TNEB Limited and upon issue of the Proceedings No. 147 dated 30.12.2025, the Chief Engineer/Personnel on 30.12.2025 has approved the internal selection list of eligible directly recruited JA / Typist to the post of Assistant Engineer/ Electrical (6-1 individual already selected and kept in abeyance as per interim Court orders), Mechanical (7-1 individual already selected and kept in abeyance as per interim Court orders) and Civil (3 nos).

3) Further informed that the selection of the employees mentioned in the annexure to the post of of AE/ Electrical / Mechanical / Civil is based on the date of cancellation of the proceedings No.47 dated 19.02.2018 and it may be stated that, their selection is considered sympathetically as a special case and they will not be eligible for requesting seniority in between the already selected candidate who were selected on merits as per the call letter, Further the eligible 16 individuals may be requested to furnish an undertaking that they will withdraw their cases and will not claim seniority, back wages etc.. to avoid future litigations.

4) The selection of the employees for appointment as Assistant Engineer/ Mechanical through Internal Selection is subject to the following conditions:-

- i) That their pay will be fixed by grant of personal pay to the extent of the difference in the basic pay admissible to them from time to time in the post of Assistant Engineer/ Mechanical till it becomes equal to or more then the basic

pay in the previous post of his promotion to higher post whichever is earlier, as per orders in B.P. Ms. (FB) No.95 (Sectt. Branch) dated 20.11.1985 and clarificatory orders issued in this regard from time to time.

- ii) Since the appointment now ordered is by Internal Selection, the individuals are not eligible for fixation of pay under Regulation 33(b) of Tamil Nadu Electricity Board Service Regulation.
- iii) They should produce satisfactory records in original regarding their educational qualification, date of birth, Community certificate, etc., before joining duty if any discrepancy is found in unqualified for the post now offered, Their selection and appointment shall be cancelled.
- iv) As they have already furnished an undertaking relinquishing the rights for further promotion in their present cadre, in the event of their appointment as Assistant Engineer/Mechanical they have no claim for further promotion in the present cadre. They will not be eligible for reversion to their parent cadre of post under any circumstances.
- v) Further, the concerned Superintending Engineer may be directed to adhere to the instructions issued in the Memo.No.68638/A18/A181/2019-1, dated 04.02.2020 regarding the Genuineness of qualification and declaration of probation.
- vi) The anomalies if any will not be considered.

5) An undertaking to the effect as stated in para 3 above along with the items (i) to (vi) under para-4 above may also be obtained from the individuals (in duplicate) before their joining as Assistant Engineer/Mechanical. One copy of the undertaking should be pasted in Service Roll/Service Book of the individual and another copy should be retained in the Office of the Superintending Engineer.

6) Necessary form of Physical Fitness Certificates are enclosed and the individual may be directed to produce the same from a Medical Officer not lower in rank than that of a Civil Surgeon to the Superintending Engineers at the time of his joining duty as Assistant Engineer/Mechanical. If their vision is not normal, then they have to produce a special certificate from an Eye Specialist employed in a Government Hospital, furnishing the particulars mentioned in the annexure to the form of Physical Fitness Certificate.

7) The fix a date of as the last date for joining duty stating if they do not join duty on or before that date, their selection orders will be cancelled without any further notification.

8) The selected candidates may be informed that this selection is subject to the outcome of Writ Petition/Writ Appeal if any filed by other employees in this regard before the Hon'ble Madras High Court and its Madurai bench.

9) The candidates may be informed that the employees appointed to any post in TANGEDCO/TANTRASCO or its successor entities by Internal Selection are eligible to

apply for request transfer within and beyond the circle after completion of one year of service in the appointed station as per orders issued in (Per) (CMD) TANGEDCO No72.dated.23.11.2021

10) The Superintending Engineer are requested to verify that the selected employees posses adequate knowledge in the Tamil Language as specified in proceedings No.42.dated.28.11.2019.

11) The Superintending Engineer should verify for any disciplinary proceedings pending/issued/ordered against the selected employee and if any is found, the selected employee may not be permitted to join duty and to report the fact to Head Quarters immediately.

12) The selected Candidates may be informed that they should **join duty within one week** from the date of relief in the present post, failing which it will be taken that they are not interested to accept the appointment and further **action will be taken to cancel their appointment.**

13) The list of names selected and enclosed herewith is as per rule of reservation only. The seniority of the individuals may be arrived latter and communicated based on the clarification to be furnished by the Government.

14) No representation for change of postings of extension of time limit to join duty will be entertained under any circumstances. Even if any attempt is made for modification through third person, the selection and appointment order will be cancelled.

15) The Superintending Engineers concerned are requested to report the date of relief and date of joining of the individual promptly.

16) If any of the individual is undergoing punishment/D.P. pending, the allotment order need not be served and intimation to this office immediately.
