

Office order No.CE/TR/SE/TR-I/EE/TSM/AEE2/F.Re org.TR/D.00332/25, dt.10.01.2025

Sub: TANTRANSCO - Establishment - Transmission HQ - Re-organising /Re-delegation of works amongst circles — to form Transmission planning wing — Orders - Reg.

- FLM NOTE (APPROVAL) : T/134/2024 approved by MD/TANTRANSCO on 03.01.2025

In the proceedings cited above orders were issued for redeployment of the SE/System Studies circle and one Master Plan Division from CE/Planning/TNPDCL towards formation of planning wing exclusively for TANTRANSCO and attached to CE/Transmission/TANTRANSCO. Accordingly the MD/TANTRANSCO has approved to form exclusive Transmission Planning wing with the following Re-organisation of Transmission wing.

A) SE/Transmission-I circle:

- The SE/Transmission-I circle shall be re designated as SE/Planning/Transmission circle.
- ii. The EE/TSM division shall be re designated as EE/ Master Plan-I/ Transmission. Apart from 2 Nos. AEE/Electrical and one No. AEE/Civil, another AEE/Elec. is required. An experienced AEE/Elec. in estimate scrutiny to be allocated to the above EE/MP I division.
- iii. The Project subjects now dealt by EE/TSM shall be reallocated to EE4 (400kV Division reallocated from SE/TR-II) attached to Transmission-IV circle. The procurement of 200MVA, 500MVA ICTs, Reactors and Capacitor Banks now dealt by EE/TSM shall be allocated to EE/Transformer of SE/TR-II circle.
- iv. The existing EE/works shall function under the SE/Planning/Transmission circle. In Works Division One vacant AE post to be filled up.
- v. The EE/Master Plan Division redeployed from TANGEDCO shall be redesignated as EE/ Master Plan-II/ Transmission is attached to SE/Transmission Planning circle with 2 Nos. AEE/Electrical. An experienced AEE/Elec. in estimate scrutiny to be allocated to the above EE/MP II division.

- vi. The Existing EE/Projects division with an AEE in SE/ Transmission-I circle shall be attached to SE/Transmission-IV .
- vii. The Administration function shall be detached from SE/Transmission I circle and attached to SE/ System Studies circle.
- viii. One new EE/ General planning division/Transmission with 2 AEE/Electrical will be formed for SE/ Planning /Transmission circle to carry out essential functions.

B) <u>SE/Transmission-II circle:</u>

- The SE/Transmission-II shall be redesignated as SE/ Material Management / Transmission.
- ii. The existing EE/Sub-station, EE/Transformer and EE/Transmission Lines divisions shall function under SE/Material Management/Transmission. Further procurement of 200 MVA, 500 MVA, Reactors and Capacitor Banks are attached to EE/Transformer division.

C) SE/Transmission-IV circle:

- i. The SE/TR-IV is to be redesignated as SE/Turnkey Projects/Transmission.
- ii. The existing EE2&EE3 divisions shall function under SE/TP-I with the name as EE/TP1 & EE/TP2.
- iii. The EE/Projects Division with an AEE being attached from SE/TR-I (SE/Planning/Transmission) circle as stated in Clause A(6) shall be re designated as EE/TP3 under SE/Turnkey Projects/Transmission.
- iv. EE/400KV Division (EE post is vacant) to be redesignated as EE/TP4 along with 2 AEEs now under the control of SE/TR-II is to be re allocated to SE/Turnkey Projects/Transmission. All the ongoing projects now dealt by EE/TSM of SE/TR-I circle is to be allocated to EE/400KV division(EE/TP4).

D) SE/TR/765 Circle:

- i. The SE/TR/765KV shall be re designated as SE/Schemes/Transmission.
- ii. The existing 765KV, Funds and Cables Divisions as EE/Schemes I, EE/Schemes III/Funds and EE/Schemes III/cables divisions shall function under SE/Schemes/Transmission circle

E) SE/System Studies Circle:

- The SE/System Studies shall be re designated as SE/System Studies/ Transmission
- ii. It shall process 765KV and 400KV estimates apart from System studies functions.
- iii. The Admin function of O/o.CE/Transmission shall be attached to SE/SS circle.

The system studies wing will be seated in the TANTRANSCO HQ Building /Vth floor. The RDSS team present in the Vth floor of Transmission wing in TANTRANSCO HQ Building shall be relocated to the existing System Studies location in TANGEDCO Building.
