3) The appointment order to the above candidate are issued with the following conditions that:-

- i) They are directed to inform that the Persons Studied in Tamil Medium clam of the above said candidates shall be referred to the appropriate authorities viz., The Director of School education / The Director of Technical Education / The Registrar/ The Controller of Examinations of Universities concerned for verification by forwarding the copy of PSTM certificates. The temporary services of the above said candidates should not be regularised in the said post until the claims are found to be genuine. The PSTM claim may be accepted after the receipt of genuineness report from the authorities concerned and if the PSTM claim is found to be genuine, the service of the candidates may be regularised by the Head of Department themselves. After acceptance of the PSTM claim of the candidates, the fact may be informed to the Commission along with a copy of the genuineness report, so as to finalise their provisional candidate is liable for such penal and legal action including recovery of salary as a consequence thereof.
- ii) The candidates selected under PSTM category, the following paragraph shall be include in the appointment order to the issued to the candidate:-

"The selection for appointment by direct recruitment to this post is purely provisional subject to verification and acceptance of genuineness of PSTM claim made in the online application. He/She is also informed that if his / her PSTM claim is found to be not genuine, subsequently, he /she is liable for such penal and legal action including recovery salary as a consequence thereof.

The TNPSC Commission has instructed the candidate with benchmark disability mentioned below who has been selected provisionally and conditionally, to request that genuineness of Certificate of Disability should be verified by referring the candidate to Medical Board to confirm the genuineness of certificate before issuance of appointment order. If the claim of benchmark disability is found as not genuine, the said candidate need not be issued with any appointment order and the fact may be informed to this office.

- IV) The selection list/Seniority of candidates is purely provisional subject to the final orders to be passed in W.Ps and other cases, relating to this recruitment if any, pending on the files of the Hon' ble High Court of judicature at Madras/Madurai Bench of Madras High Court and in the Hon'ble Supreme Court of India.

"The appointment is temporary and selection is made based on his/her claims made in his/her application for the said recruitment and that if any of his/her claims is found to be false, his selection and appointment will be cancelled without any further notice".

- v) The certificate of physical fitness may be called for from the candidates and same may be verified regarding their fitness by the competent authority based on the guidelines issued in Adm Branch Memo No.134/730/R.II(1)85-1, dt.20.12.1995 (Published in TNEB Gazette).
- vi) The selection list containing the photograph of the selected candidates is send herewith for verification of the identify of the candidates at the time of their appointment.
- vii) The applications of candidates mentioned in the selection list are admitted finally, except the candidates mentioned in para no 2 and their temporary services may be regularised from the date of their joining duty afer verification of their PSTM and certificate.

- viii) The appointment order to be issued to the candidates to the effect that no kind of representation regarding joining time will be entertained and that if the candidate fails to join duty within the specified time and at the specified place, the candidate's name will be deleted from the approved list of candidates selected to the above said post. As per Rule 8A of Tamil Nadu Public Service Commission – Rules of Procedure, the names of such candidates may be deleted by by the Appointing Authority themselves and the fact of deletion may be intimated to this office.

"The regularization is subject to outcome of the cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment".

As soon as the candidates selected for appointment to the said post join duty, it may be ascertained from them as to whether they have registered their name with any Employment Exchange. If so, they may be asked to surrender their Employment Exchange identity card, and it may be sent by you to this office, so that the registration of the candidates concerned may be removed from the Live Register of the Employment Exchange.

- IX) All the selected candidates possessed adequate knowledge in Tamil.

4) In this connection, it is request you to arrange to verify the following original certificates by the responsible officer of your circle.

- i) They should produce satisfactory records in original relating to his/her educational qualification, date of birth, Community etc., at the time of before joining duty. If any discrepancy is found to unqualify for the post now offered, his/her selection and appointment shall be cancelled.
- ii) Candidate should produce the undertaking in Rs.100/- stamp paper along with the certificate of Physical Fitness obtained from a Medical Officer not lower in rank than that of a Civil Surgeon. In Case of differently abled persons, relevant certificates may also be verified.
- iii) If he/she is employed, he/she should get proper relief from present employer before joining the services of TANGEDCO.

5) The selected candidates should work in their allotted place until completion of two years and shall not be eligible to make any application requesting transfer to any

other circle/office under the control of any other appointing authority and, until completion of one year, shall not be eligible to make such application within the circle/office under the control of the same appointing authority as per orders issued in (Per) (CMD) TANGEDCO Proceedings No.72 (Adm. Branch), dated 23.11.2021.

6) The selected candidates may be appointed in the level 1 of pay matrix for Officers at Rs.39800-126500/- as Assistant Engineer/Civil on probation for two years.

7) Necessary Genuineness Certificate of the candidates have to be obtained from the concerned Educational Department for the Educational Qualification before declaration of probation as instructed issued in Secretariat Branch Memo. No. 68638/A18/A181/2019-1, dated 04.02.2020.


