PROCEEDINGS:

The Government in its order first read above have issued orders constituting a committee to examine in detail the three Pension Schemes, viz., Contributory Pension Scheme, Old Pension Scheme and Unified Pension Scheme under the Chairmanship of Thiru.Gagandeep Singh Bedi, IAS, Additional Chief Secretary to Government, Rural Development & Panchayat Raj Department (Chairman), Dr.K.R.Shanmugam, Former Director/Madras School of Economics (Member) and Thiru.Pratik Tayal, IAS, Deputy Secretary (Budget), Finance Department (Member Secretary). It was also ordered therein that the committee shall submit its detailed report and recommendations to the Government within a period of nine months.

The Deputy Secretary (Budget), Finance Department (Member Secretary)/ Pension Committee in letter second read above, has stated that in order to undertake an analysis, the Committee is seeking to collect data of existing employees, pensioners/family pensioners and retirees under Contributory Pension Scheme in the agencies/institutions and autonomous bodies, which adopt policy of Government in regard to pension. A Preliminary Meeting was convened by the Deputy Secretary (Budget), Finance Department (Member Secretary)/Pension Committee on 24.06.2025 at Secretariat to brief the data requirement and has requested the Chairman and Managing Director/TNPDC to depute the concerned officer from TNPDC to attend the Meeting. Further, it has been requested to furnish the required data to the said Pension Committee with authenticated copies marked to the Finance (BPE) Department – vide Government's letter third read above. After detailed examination, it has been decided to appoint a Nodal Officer to collect the required data from the concerned offices and to furnish the same to the Committee.

Accordingly, it is hereby ordered that the Chief Internal Audit Officer/Audit Branch, be appointed as Nodal Officer on behalf of TNPDCCL for collecting and submitting the details required by the Pension Committee formed by the Government in G.O. first read above through Government/Finance (BPE) for Evaluation and Analysis of Contributory Pension Scheme, Old Pension Scheme and Unified Pension Scheme in respect of the employees of TNPDCCL. Further, the CIAO/Audit Branch is hereby instructed to attend the meetings to be convened by the said Pension Committee without fail and to submit the report to the CMD/TNPDCCL with a copy marked to the Secretary/TNPDCCL.
