TANTRANSCO Board has accorded approval for the the following amendment to the existing provision in B.P.Ms.(F.B.)No.18 (Accounts Branch) dt.18.7.88, with respect to the powers of the condemnation of the Plant, Machinery and Tools , which have served their full life period and assessed values are adopted in the condemnation proposal:

	the approval of the authority next higher than the one prescribed, should be obtained for condemnation".
