Note:

- 1.The tender powers of low value procurement can be exercised by the Tender Inviting Authorities up to the limits prescribed in Rule 33 of Tamil Nadu Transparency in Tender Rules 2000 (Presently for procurement of materials and services, the limit is "not exceeding Rs.25 lakhs". For works contract, presently the limit is "not exceeding Rs.50 Lakhs").
- 2.The powers can be exercised by the concerned person (i.e., CE,SE & EE) so long as the bids received do not exceed the estimate cost. Whenever the final bid price exceeds the estimate cost, the same may be placed before the next higher level tender accepting authority.
- 3.The value of hiring vehicles shall not be taken into account for arriving the ceiling limit in a financial year since the hiring of vehicle is being done by the CEs/SEs, as sanctioned by the BLTC.
