Sub: Technical Assistant / Mechanical stagnated without JE II Grade promotions -
Calling for of Suitability for filling up of the vacant posts -requested regarding

Persons working in the post of Technical Assistant / Mechanical have been left stagnated without Promotions for more than a decade. Legal proceedings in a Seniority case has been a reason for this due to which promotions for the post of Junior Engineer / Mechanical I Grade could not be operated leading to cascading stagnation in this Junior Engineer / Mechanical category.

The pathetic condition is some of the Technical Assistant / Mechanical who had attained Selection grade a couple of years ago are yet to get their due promotions and few among them are going to superannuate shortly. Our Sangam has been representing to clear this legal proceedings which is still languishing in the Court. The steps taken so far hasn't been fruitful yet leaving this category in total desperation.

We understand that presently more than 15 Nos. posts are vacant in Junior Engineer / Mechanical II Grade and few more vacancies are going to arise shortly. Considering the present vacancies and the arising vacancies calling for of suitability for promotion to the post of Junior Engineer / Mechanical II Grade would be very much beneficial to the individuals deprived of promotions.

Moreover due to this promotion of Junior Engineer / Mechanical II Grade, vacancies would arrive in the post of Technical Assistant / Mechanical paving way for compassionate appointment for the Diploma Mechanical qualified wards who are waiting for their turn of appointment for the past few years.

Hence we request the respected Chairman cum Managing Director to take necessary steps for calling for of suitability for promotion to the post of Junior Engineer / Mechanical II Grade benefitting the present Technical Assistant / Mechanical and also the individuals and their families who are eagerly waiting for compassionate appointment for the post of Technical Assistant / Mechanical and thus render justice please.
