### ORDER:

In the Government Order first read above, orders were issued for suspending the periodical surrender of Earned Leave for encashment for 15 days every year / 30 days every two years initially for a period of one year with effect from 27.04.2020. In the Government Order second read above, orders were issued extending the suspension of facility of surrender of Earned Leave for encashment for one more year till 31.03.2022. Subsequently, in the Government Order third read above, the suspension of facility of surrender of Earned Leave for encashment has been extended until further orders.

2. The Hon'ble Chief Minister has made the following announcement on the floor of Tamil Nadu Legislative Assembly under rule 110 of the Tamil Nadu Legislative Assembly Rules on 28.04.2025:-

கோவிட்-19 பெருந்தொற்றுக் காலத்திலே, அரசின் நிதிநிலையின் மீது ஏற்பட்ட பெரும் சுமையின் காரணமாக நிறுத்தி வைக்கப்பட்டிருந்த அரசு அலுவலர்களுக்கான ஈட்டிய விடுப்பு சரண் செய்யும் நடைமுறையை, 01.04.2026 முதல், 15 நாட்கள் வரை சரண் செய்து பணப்பலன் பெறும் வகையில் மீண்டும் செயல்படுத்தி 2025-2026 ஆம் ஆண்டுக்கான நிதிநிலை அறிக்கையில் அறிவிப்பு வெளியிடப்பட்டது. இருந்தாலும், அரசு அலுவலர்கள் மற்றும் ஆசிரியர்கள் இந்த அறிவிப்பை, இந்த ஆண்டே செயல்படுத்தி கோரிக்கை வைத்திருக்கிறார்கள்.

அரசு அலுவலர்கள் மற்றும் ஆசிரியர்களுடைய கோரிக்கையைப் பரிசீலித்து, ஈட்டிய விடுப்பு நாட்களில், 15 நாட்கள் வரை 01.10.2025 முதல் சரண் செய்து பணப்பலன் பெறலாம்."

3. Based on the above announcement made by the Hon'ble Chief Minister, the Government issue the following orders:-

- (i) the Earned Leave surrender system be restored with effect from 01.10.2025;
- (ii) the encashment of Earned Leave for 15 days in a year be allowed to Government Employees and Teachers as per their regular annual cycle according to the due date prior to the suspension of the facility on 27.04.2020;

- (iii) the Government Employees who have joined service between the period from 27.04.2020 to 30.09.2025, if otherwise eligible, are allowed to encash by surrendering the earned leave for 15 days from the first day of the quarter in which they have joined as per the schedule given below:-

Joining in Government service in between 27.04.2020 and 30.09.2025	Eligible from
October, November, December	01.10.2025
January, February, March	01.01.2026
April, May, June	01.04.2026
July, August, September	01.07.2026

4. It is clarified that if a Government Servant had surrendered the Earned Leave for encashment for 15 days on 01<sup>st</sup> April, 2020, he/she will be eligible to avail this facility on 01<sup>st</sup> April, 2026 and if he/she had surrendered it on 15<sup>th</sup> October, 2019, he/she will be eligible to avail this facility on 15<sup>th</sup> October 2025.

5. This order is also be applicable to all Constitutional/Statutory Bodies including all State Corporations/ Local Bodies/ Boards/ Universities/ Commissions/ Companies/ Institutions/Societies, etc.

6. Necessary amendment to Rule 7A of the Tamil Nadu Leave Rules, 1933 in this regard will be issued separately.
