As per the approval of the CMD/TANGEDCO, instruction has been issued vide reference (1 & 2) cited, to incorporate the General Conditions (Statutory Compliances) uniformly in all the Tender Specification/ Agreement/ Acceptance orders of the works contract and also in the contracts in which the scope of the work has been included with supply of materials in TANGEDCO & TANTRANSCO.

2) Recently, certain unions have requested to issue an Accidental Insurance Scheme for the Labours engaged by the Contractors.

3) The request of the unions has been examined in detail and approval has been accorded that, all the contractors executing the works contract/ contract in which labours are engaged should provide an accidental insurance scheme for Rs.2,00,000/- additionally under Pradhan Mantri Suraksha Bima Yojana (PMSBY) scheme through the Bank/ Post Office for a premium of Rs.20/- per annum per person, to all the labours engaged by them for the works in TNPDC, TNPGL, TNGECL and TANTRANSCO.

4) Accordingly, the above conditions shall be included in the tender specification/ agreement/ acceptance order additionally in the existing General Conditions (Statutory Compliances), so as to implement the same without any lapse.

5) All the Chief Engineers and Superintending Engineers of TNPDC, TNPGL, TNGECL and TANTRANSCO should adhere the same without any lapse.
