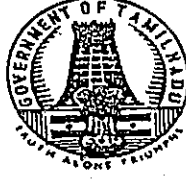

Transport Department - Motor Vehicles - Validity of registration of Government Vehicles more than 15 years old including the State Transport Undertaking buses - Extension upto 30.09.2025 - Executive order to be issued - Direction to the Transport Commissioner - Orders - Issued.

ORDER:-

The Principal Secretary / Transport Commissioner, in letter third read above, has stated that the Government of India in the Ministry of Road Transport and Highways has issued a notification first read above, inserting Rule 52A in the Central Motor Vehicles Rules, 1989 by which, the Ministry of Road Transport Highways stipulated that all those Government owned vehicles which are more than 15 years old are to be scrapped and that the Registration Certificate of the vehicles covered by the Government Departments were unilaterally cancelled by the Ministry of Road Transport and Highways with effect from 01.04.2023 through the Vahan portal. Based on the above Notification, the 'Renewal of Certificate of Registration in respect of motor vehicles owned by the State Transport Undertakings and other Public Sector Undertakings shall expired after the lapse of 15 years from the date of initial registration of the vehicles.

2. In the Government order second read above, orders were issued extending the validity of Registration of 6341 Government vehicles including State Transport Undertakings and various Government Departments local bodies of Tamil Nadu, which have been 15 years old and 15 to 20 years old

vehicles (on Road) whose Registration Certificate has been cancelled in Parivahan. Further, the Transport Commissioner has also been directed to issue an Executive Order permitting the Regional Transport Officers to extend the validity of Registration Certificate upto 30.09.2024, and to direct the Regional Transport Officers to issue manual Fitness Certificate and also allowing collection of the tax for those vehicles and do the renewal of the Fitness Certificate, manually.

3. The Principal Secretary / Transport Commissioner has also stated that, on receipt of further representations from the State Transport Undertakings and other Departments involved in essential services such as Ambulances, Fire and Rescue Services vehicles, Police Vehicles, etc., deployed for the maintenance of Law and Order, Health and Family Welfare, Public Distribution System etc., to further extend the validity of Registration Certificates of those department vehicles which are going to expire on 01.10.2024 shall be further validated manually up to 30.09.2025 to provide affordable Public Transport and extend essential services through Government Departments for the safety, security and protection of the common public.

4. The Principal Secretary/Transport Commissioner has requested the Government, out of 14611 vehicles belonging to Government and Government Undertakings, the 6247 vehicles of older than 15 years which are plying on road, as of now, may be ordered to extend the validity of Registration Certificates for further period of one year or until 30.09.2025 and also requested to issue an order directing him to issue an Executive Order permitting the Regional Transport Officers to further extend the validity of Registration Certificates of 6247 vehicles upto 30.09.2025 and to authorize the Regional Transport Officers to make manual collection of tax and grant /renewal of fitness Certificates in respect of those vehicles which need to be renewed manually, after 01.10.2024, thereof.

5. Since, it is the prime responsibility of the State Government to provide affordable public transport and provide essential services through Government Departments for the safety, security and protection of the common public and it is essential to ply these de-registered vehicles, in public interest, subject to road worthiness of the vehicles, the Government, after careful examination, have decided to accept the proposal of the Transport Commissioner. Accordingly, the Government issue orders to extend the validity of Registration of 6247 vehicles (on Road) out of 14611 vehicles belonging to Government and Government undertakings, for the further period upto 30.09.2025, whose Registration Certificates are going to expire on 01.10.2024.

6. The Transport Commissioner is therefore directed to issue an Executive Order permitting the Regional Transport Officers to extend the validity of Registration Certificates of 6247 vehicles upto 30.09.2025 and to authorize

the Regional Transport Officers to issue manual fitness certificate and also allowing collection of tax for the above vehicles and do the renewal of the fitness certificate manually after 01.10.2024.
