READ: Approval accorded by Board of TNPDCL (erstwhile TANGEDCO) in the 128th Board Meeting of TNPDCL held on 20-02-2025.

PROCEEDINGS:

In order to ensure prompt and proper assessment with more accuracy, the assessment through Mobile App has been introduced as a pilot study which showed successful results. While assessment through Mobile App in pilot study, most of the issues already sorted out but still there is a demand of separate mobile to take assessment due to several issues experienced during assessment/data transfer. Also Various trade unions made a request to provide a separate mobile phone to the assessment staff. After critical examining the request/demand, by stating the issues faced by the assessment staff, Board of TNPDCL (erstwhile TANGEDCO) has approved the proposal for reimbursement of cost towards android mobile for taking assessment through Mobile App for assessment staff:

1. To accord in principle approval to sanction Rs.10,000/- (Rs. Ten Thousand Only) each towards cost of android mobile/tab to the assessors based on their request and declaration to use their own android Mobile/Tab or purchase new android mobile/Tab for the assessment and related works assigned to him.
2. To accord in principle approval to sanction Rs.10,000/- (Rs. Ten Thousand Only) each towards cost of android mobile/tab to the Inspector of Assessments who are engaged in the regular assessment against the assessor post vacancy and they look after the post for continuous six months on the date of making request.
3. Retired staff and other personnel engaged for assessment work by the contractor under works contract or any other contract are not eligible for reimbursement.

4. The eligible assessment staff those who have minimum remaining service of 6 months can claim and get reimbursement of Rs. 10,000/- in one lumpsum.
5. To Authorise the Superintending Engineer/EDC concerned to sanction the reimbursement and to pass the bill for payment by adding the same in the salary bill of the respective eligible assessment staff.
6. To book the expenditure under ERP code: 4070128 - miscellaneous expenditure.
