Sub: Sanctioning of posts for the newly formed Sections, newly commissioned Substations and Power Projects - Kept pending for quite long -Kind intervention of Respected Chairman cum Managing Director requested - regarding.

Board enters into Work Load and Wage Revision Settlement (12 (3) Settlement) with recognised unions periodically every 4 years. While the last settlement for Wage Revision took place in 2023 the settlement previous to this one on Work Load and Wage Revision took place on 22.02.2018.

During that 2018 settlement New Sections – 63 Nos. in Distribution areas were formed. It's really worrying that post sanction (All categories as per norms) for these newly formed sections are yet to be made. For few sections the field staff alone has been sanctioned. The Board has not honoured its settlement.

Similarly new substations (110KV, 230KV, 400KV & 765KV) around 89 Nos. have been constructed and commissioned in many places due to expansion of power network. Alas the post sanction (All categories as per norms) for these newly commissioned substations are yet to be made.

These newly commissioned Substations cannot function without manpower. Hence presently Engineers and Staff from the nearby Substations and Distribution

areas are being diverted / deputed for these works. This paralyzes the routine works in the Distribution areas and the erstwhile Substation which could be avoided.

Numerous representations have been submitted by us in this regard requesting post sanction for the newly formed sections and newly commissioned substations. The matter was discussed in detail with then respected Chairman cum Managing Director during our discussion on 17.02.2021 and numerous other occasions.

Yet the matter is kept pending making mockery of the system in these newly commissioned Substations which cannot be put here in words. Really can't understand how Board which invests crores of rupees for the expansion of Power network is least bothered about Substations operation and safety aspects.

The same applies to Generating Stations too where the huge investment made in Power Projects is getting delayed for its implementation due to dearth of Engineers and Staff and in some cases nil Staff. Board is considering to run these Power Plants through Redeployment or through Outsourcing which is quite ridiculous which may cause huge financial loss and dent its image.

We presently bring this matter to the present respected Chairman cum Managing Director and request to introspect the matter wholly and do the needful for clearing the hurdles whatsoever for sanctioning of posts in all these newly formed Distribution Sections, newly commissioned Substations and newly commissioned Generating Stations thereby improve stability in our electrical network and easing the operation works please.

Amendment to Service Regulations 94 and 98 of Tamilnadu Electricity Board Service Regulations were issued vide reference - 1 cited. The amendment to the regulations were issued in haste without considering the ground realities or practical implications in the field targeting few categories without following the procedure, hence needs to be withdrawn.

The service conditions of Employees in Board are governed by the Service Regulations strongly in force for the past six decades. All along these 6 decades of history, any amendment to the Service Regulation has always been done benefitting both the Employees and the Board with due intimation through 9A Notice or with due discussion or with the knowledge of the unions, which wasn't done in this case.

Many orders sinister in nature were executed and passed in the Board during the COVID period. Few such orders have been withdrawn for which we are very much thankful to the Board. Yet our representations on withdrawal of this Service Regulation amendment vide references 2 to 7 above is unheeded till date.

Due to this amendment, promotion avenues of both our Diploma categories namely Junior Engineer II Grade and Junior Engineer I Grade are worsely affected and promotions couldn't be issued in time as per ratio governing these categories which are covered under the Work Load settlement. Moreover Board works too gets affected as the huge vacancies couldn't be filled up which is a matter of concern.

Our concerns on this issue were presented in detail to the then respected Chairman cum Managing Director during the discussion held on 17.02.2021. During that discussion then respected Chairman cum Managing Director had assured us of a favourable decision on this matter which is still pending.

We had raised our concerns yet again during the last Wage Revision discussion held during 2023. We were assured of a positive result by the Board yet again during the discussion.

Hence we presently bring this matter to the knowledge of the respected Chairman cum Managing Director for kind consideration, requesting to withdraw the amendment order in dispute cited under reference – 1 and thus render justice and maintain industrial peace please.

Sub: Promotions and Internal Selection for the Diploma category in Mechanical Branch is totally stalled – Individual case on Seniority is the root cause – Intervention requested to clear the case and issue promotions - regarding.

Diploma qualified persons enter in the Board as Technical Assistant and get promoted as Junior Engineer II Grade and Junior Engineer I Grade over a period of 10 to 15 years of service and very few have a chance to reach the post of Assistant Executive Engineer around 30 years of service on the verge of retirement.

The above scenario applies all three Branches of Electrical, Mechanical and Civil with a slight correction in Civil Branch alone who enter the Board as Draughtsman and other lower level posts as there is no Technical Assistant Post in Civil Branch.

Of late the promotion stream of Mechanical Branch is in totally freezed condition due to an individual case in the Hon'ble High Court of Chennai belonging to the post of Junior Engineer / Mechanical II Grade disputing seniority. The case is languishing in the Court for almost a decade.

As direction has been issued in this case not to proceed further on Promotions, Board couldn't issue the Junior Engineer / Mechanical I Grade promotions and consequent Junior Engineer / Mechanical II Grade promotions too for want of vacancy and also literally blocking the Technical Assistant / Mechanical intake by all means.

Many of the Technical Assistant / Mechanical have completed 12 to 13 years of service and their sufferings are untold as their counterparts in Electrical Branch have already got 2 promotion and working as Junior Engineer / Electrical I Grade.

Moreover Board is not even able to issue Compassionate Appointment to the wards of the deceased Employees who have completed Diploma in Mechanical Engineering and the families of the deceased are in total sufferings.

The individual who had filed the case has retired from Board's Service almost a year ago, yet there isn't any development in this case and issuance of subsequent Promotions and Postings.

Hence we pray the intervention of the respected Chairman cum Managing Director in this matter and request to do the needful to vacate the stay in the individual case and thereby process the promotions of Junior Engineer / Electrical I Grade and Junior Engineer / Electrical II Grade and Technical Assistant intake in the Mechanical Branch thereby brightening the lives and career of Mechanical Diploma holders and thus render justice please.

Umpteen times have we represented the Administration highlighting the significance of Assistant Executive Engineer as Sub divisional head, yet the Management is least bothered on the consequences and going ahead with this order cited under reference.

Hence we pray the intervention of the respected Chairman cum Managing Director in this matter and request to do the needful to withdraw the order cited under reference thereby saving the name of the Board among the public in Distribution areas and thus render justice please.

Strict rules and guidelines is being followed in the Board for revocation of suspension of Officials. While the case is being dealt separately for cases involving Criminal and DV & AC cases, the procedure for other cases are being followed scrupulously at both Circle / Region level.

The process involves revocation of suspension and subsequent allotment orders. Earlier both these procedures were handled at Circle / Region level based on the individuals post but presently revocation procedure alone is made at Circle / Region level while allotment orders are posted by Head Quarters as per orders cited under reference.

Sub: Sanctioning of Additional Charge Allowance of AEEs and AEs working in Hydro Power Stations and Gas Turbine Power Stations – Clarification Orders passed earlier hasn't been effected for these areas – Insisting revised clarification orders – requested regarding.

Ref: Memorandum (Per.) No. 39468/A17/A171/2020 - 4, Dated 18.07.2022.

All Officers and Engineers working in the Board are eligible for drawing Additional Charge Allowances whenever they look after an additional post. But this was denied to Assistant Executive Engineer and Assistant Engineer working in Generating Stations and unnecessary audit slips were raised due to misinterpretation of orders in vogue.

This led to chaos in the field at Generation areas and our Sangam took up this matter to the respected Chairman cum Managing Director, respected Director Generation and other Officials of the Board requesting to extend this feature to the Assistant Executive Engineer and Assistant Engineer of Generating Stations also on par with their counterparts in Distribution areas.

The matter was introspected thoroughly and clarification orders were issued vide reference cited above. At the time of issuing the clarification orders Board had concentrated totally on Thermal Power Stations alone without mentioning anything about allowing this feature to Hydro Stations and Gas Turbine Power Stations.

Due to this ambiguous clarification orders, Additional Charge Allowance couldn't be implemented in all Generating Stations uniformly.

- The categories of Assistant Executive Engineer and Assistant Engineer working in Thermal Power Stations are sanctioned Additional Charge Allowance since then for which we are thankful to the Administration.
- The categories of Assistant Executive Engineer and Assistant Engineer working in Hydro Power Stations were too sanctioned Additional Charge Allowance until 6 months ago which has been stopped without reasons presently.
- The categories of Assistant Executive Engineer and Assistant Engineer working in Gas Turbine Power Stations are denied Additional Charge Allowance till now.

Moreover the audit slips have been raised in Gas Turbine Power Stations and huge amount is being recovered from these Assistant Executive Engineer and Assistant Engineer categories for the Additional Charge Allowance allowed earlier.

It is a cruel treatment on the categories who have carried out their Additional Charge duties sincerely. Few of them are in the verge of retirement which makes the conditions more pathetic.

It is really perplexing that an order of the Board is not being implemented uniformly for all categories working in all areas of similar in nature.

Hence we pray the intervention of the respected Chairman cum Managing Director in this matter and request to do the needful to

- Drop all the Audit Slips raised against Assistant Executive Engineer and Assistant Engineer with regards to Additional Charge allowances working in Gas Turbine Power Stations.
- Introspect the matter thoroughly and issue revised clarification orders extending Additional Charge allowances for all Assistant Executive Engineer and Assistant Engineer categories working in Gas Turbine Power Stations and Hydro Power Stations also.

Thereby adopt uniform policy and thus render justice and industrial peace, please.

Alternative arrangements for smoothening this matter needs be done in war footing for better functioning please and we request restoration of 5 Nos. personnel in each location as provisioned earlier.

Sub: Inordinate delay in sanctioning of Pay Anomaly – easing of procedure to benefit the individual – requested regarding.

Disparity in pay between Senior and Junior is settled through Pay Anomaly. Lot of procedure is being followed for applying it and a Senior who applies for it need to fulfill all these conditions before submitting it at the Circle level. The proposal is then scrutinized and sent to Head Quarters for approval. This process normally takes few months and in few cases a year for sending it to Head Quarters.

The proposal after reaching Head Quarters is mostly kept idle or processed in snail's pace for reasons well known to the Administration. This doesn't augment well as in most cases takes in order of years for sanction or sent back with a query. By this time the anxious Employee almost forgets his pending plea or retires from the service.

Adding fuel to this cumbersome procedure, Board has formulated a committee for scrutinizing the Pay Anomaly proposal before sanction. Sending the proposal through the committee is a good one so as to avoid misuse of this feature as it involves huge financial commitment to the Board.

But this procedure too is yet to takeoff and the same saga of delay continues. The management is duty bound to settle the grievances of is Employees in a stipulated time, which isn't happening.

Hence we pray the intervention of the respected Chairman cum Managing Director in this matter to find a solution to ease this procedure and thus bring solace to the Employees of the Board and thus render justice please.

Sub:Matters of importance related to Generating Power Stations-regarding.

The following matters of importance pertaining to Power Generating Stations are enumerated for necessary action please.

Avoiding frequent hand tripping and light up of Thermal Power Stations:

Thermal Power Stations are Base Load Power Stations and as recommended by the OEM they have to run to its full load capacity. Hence they need to be put into continuous service without taking out of bars due to grid variation. This is the strict recommendations stipulated by NTPC also.

Of late Thermal Power Stations are operated as Peak Load Power Stations and subjected to frequent tripping and light ups. This not only incurs heavy financial loss to the Board but also reduces the lifetime of the Plant which is a matter of serious concern.

Operating Thermal Power Stations in intermittent manner leads to frequent punctures in Boiler tubes, failures in the Turbine blades and problems much more.

Current scenario needs to be avoided and these Plants needs to be run to its full load capacity always without much variations.

Augmentation of Ash Evacuation System in 600 MW Power Plant in Mettur:

In Mettur Dam there are two Power Plants, the 1st one MTPS – I is of 210 MW x 4 Nos. capacity, commissioned around 4 decades ago and the 2nd one MTPS – II is of 600 MW capacity commissioned during the year 2012.

The old Plant is running successfully contributing a major share of Power to the Grid even after so many years but the problems in the newly commissioned Plant are aplenty after just crossing a decade.

The culprit is the Ash Handling System which is inadequate in evacuating the ash load generated from the burnt coal. While the problem is Ash Handling System curtailed the Power Generation initially it later started polluting the atmosphere within the Plant and posing threats to the Machinery and the Personnel working in the Plant.

Presently it is creating a great danger to the environment of the City in particular to the hamlets situated nearby which is a matter of great concern. Agitations and demonstrations by the affected Public and Organizations is being held frequently.

The steps taken by the Officials so far is inadequate as they are all temporary measures which is being made taking mere financial aspects into consideration but the need of the hour is augmentation the total Ash Handling System as being done in North Thermal Power Station - II recently.

Augmentation of Ash Handling System in MTPS – Il needs to be done on war footing benefiting not just the Board but also the Machinery, Personnel working in the Plant and Public residing in the nearby villages.

• Ensuring adequate allocation of Gas to VGTPS and revival of TKGTPS:

Gas Turbine Power Stations are one of the major source of Power Generation to our Grid.

- The Power Plant in Basin Bridge is a Peak Hour Generation Plant using Naphtha as fuel which is of 120 MW (30 MW x 4 Nos.) installed capacity.
- The Board has 3 other Gas Turbine Stations which are operated as Base Load Power Stations situated at Kuttalam of 101 MW, at Thirumakottai of 107 MW and Valuthur of 187.20 MW installed capacity using natural gas as fuel.

- ➤ The 107 MW Power Plant at Thirumakottai was closed last year due to shortage of gas. Revival of this Plant has turned futile so far.
- The 101 MW Power Plant at Kuttalam is working satisfactorily contributing a reasonable amount of Power to the Grid.
- ➤ The 187.20MW Power Plant at Valuthur which has been running successfully so far is being curtailed its Generation to 50 % recently for the past 6 months due to inadequate supply of natural Gas.

The authorities concerned need to be addressed for adequate allocation of Natural Gas for Valuthur Plant and also for revival of Thirumakottai Plant.

Moreover GTS serves as a savior of the grid during emergency as it can be brought back to service in no time during such crisis.

We earnestly pray the intervention of the respected Chairman cum Managing Director in thematters enumerated above and expedited action benefitting the Board please.

The following matters of importance pertaining to Distribution areas are enumerated for necessary action please.

Essential Materials required for maintaining Uninterrupted Power Supply:

- Tinned Copper Fuse wire.
- LT UG 4 x 240 Sq. mm and 4 x 120 Sq. mm Cables
- Distribution transformers 100, 250 & 500 KVAs
- Meters 5-20 A (Single Phase) & 10-60A (Three Phase)
- Distribution transformers Oil (RC Oil)
- Line materials Stem bolts, "U" Clamps and Hexagonal Insulators
- 33 KV & 11 KV AB switch
- 11 KV structure materials
- 11 KV & 33 KV Fixed and moving contacts.
- 11 KV & 33 KV, LT Cable straight joint kits.
- PT & PIN insulators (11KV, 33 KV & LT)

Some of the above said materials are not available for the past three months., which needs immediate procurement.

Strengthening of FOC:

The Operation of the FOC centres may be extended upto subdivision level to attend the Fuse of calls and for better consumer satisfaction.

Engaging of outsourced telephone operators in the FOC centres as done earlier needs to be restored for improving the efficiency of attending the Minagam Complaints.

Enhancement of daily rental limit and ceiling limit for the FOC vehicles need to be done for speedy restoration of supply and for better consumer satisfaction.

• Essentials required for RMU Maintenance:

Most of the RMUs are in defective conditions making restoration of supply more difficult and time consuming.

Defective RMUs to be rectified and brought back to service immediately for which separate RMU wing needs to be formed.

Availability of Vehicles in field :

Works carried out by the special fields like MRT, Special Maintenance, GRT, GIS, Lines, Cables, HT Mobiles, etc., are totally dependent on vehicles. More over vehicles for the field officers too could not be engaged. The daily rental limit and ceiling limit for utilizing these vehicles is currently inadequate which needs to be enhanced immediately.

Availability of lorries for transporting materials to the field is highly essential without which the works are getting affected totally. Provisioning of lorries to the field is highly essential for effective maintenance of field works which needs to be settled immediately.

Merging of Multiple Mobile Apps :

Too many apps are being in existence for registering and communicating the daily work progress in the field making the work cumbersome. To ease the present condition these APPs needs to be merged in to a single APP making it user friendly and effective.

We earnestly pray the intervention of the respected Chairman cum Managing Director in the matters enumerated above and expedited action benefitting the Board please.
