PROCEEDINGS:

In the Proceedings read above, orders have been issued dispensing with the method of "Internal Selection" for appointment of officials/employees to all the posts with effect from 7th June 2022, subject to the condition that the Internal Selection shall be considered for existing staff who have already acquired the qualification as per the provisions of TNEB Service Regulations. A proposal for incorporating a new provision to this effect, in the Tamil Nadu Electricity Board Service Regulations has been evolved and the Board of TNPDCL in its 128th Meeting held on 20.02.2025 has approved the same.

2. Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003, G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010 and G.O.Ms.No.32, Energy (B2) Department, dated 06.03.2024, the Tamil Nadu Power Distribution Corporation Limited (formerly Tamil Nadu Electricity Board) makes the following amendments to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENT

In the said Regulations, in regulation 87, under sub-regulation (10-A), the following Proviso shall be added, namely:

"Provided that on and from 7th June 2022, the method of appointment to all the posts through Internal Selection is dispensed with. However, the employees who had already acquired the qualifications which are prescribed as pre-requisite qualification for appointment to the posts, before 7th June 2022, shall be considered for appointment to the posts through Internal Selection."
