In the reference 1<sup>st</sup> cited, instructions have been issued for revocation of suspension pertaining to Disciplinary Proceedings cases (**other than Criminal & DV&AC cases**) in respect of the officials whose suspension were prolonged for more than one year, without prejudice to the Disciplinary Proceedings/existing Court cases pending against them and send such order to Administrative Branch for issue of posting orders.

2. Further, vide reference 2<sup>nd</sup> cited, it has been instructed that if the Authorities competent intend to revoke the suspension without prejudice to the Disciplinary Proceedings/existing Court cases, (**other than Criminal & DV & AC cases**), on administrative reasons, shall

- (i) in respect of provincial employees, communicate all the orders of revocation of suspension for issue of necessary posting orders by Administrative Branch; and
- (ii) in respect of RWE employees, it may be ensured that they are accommodated in the non-sensitive post, till the conclusion of such proceedings.

3. The compendium of instructions on review of suspension cases pending enquiry into grave charges and the time limit for finalization of Disciplinary

Proceedings issued by the Government vide reference 3<sup>rd</sup> cited was communicated to all the Disciplinary authorities for strict adherence vide reference 4<sup>th</sup> cited.

4. In the reference 5<sup>th</sup> cited, it was requested among other things that to revoke the Officers/Employees who were placed under suspension "**more than 90 days**" related to Departmental D.P. cases/ Departmental & Non-Departmental Criminal cases (Except DV&AC Cases) as the case, revocation of suspension may be considered without prejudice of the outcome of Departmental Proceedings/ Criminal Proceedings (Except DV&AC Cases) filed against them and they may be posted in the non-sensitive places as per instructions issued in Memo No.074540/ 823/ G.7/ G.71./ 2020-4, dt. 20.01.2021.

5. In this regard, it is reiterated that to review and revoke the suspension in respect of Officers/Employees in Class II to IV service pertaining to DV&AC Cases pending inquiry into grave charges in consultation with the DVAC as per the G.O (Ms). No.81 HRM (N) Dept, dated. 04.08.2022, communicated in the Memo.(Per) (Sectt. Branch) No.31013/ A17/A171/2022-1, dated. 29.10.2022 without any deviation and to finalize the D.P in the time limit prescribed therein.

6. To revoke the suspension of Officers/Employees in Class II to IV service pertaining to Departmental D.P. cases/ Departmental & Non-Departmental Criminal cases as per the instructions in letter No. 003473/ 26/ G.47/ G.47(1)/2025, dt. 27.01.2025.

7. The report regarding the above may be sent to this office on a monthly basis in the Annexure I & II enclosed herewith.
