## PROCEEDINGS:

Consequent on the recognition of Tamil Nadu Electricity Board Engineers' Sangam with the Certificate of Registration first and second read above and the Tamil Nadu Electricity Board Employees' Federation in the Proceedings with fourth read above, the need for re-constituting the Apex Level Joint Committee and Unit Level Joint Committee ordered in the Proceedings third read above has arisen.

The representative will be from 1) Tamil Nadu Electricity Workers Federation, 2) Tamil Nadu Electricity Board, Accounts & Executive Staff Union, 3) Tamil Nadu Minvariya Thozhilalar Munnetra Sangam, 4) Central Organisation of Tamil Nadu Electricity Employees, 5) Minsara Pirivu Anna Thozhir Sangam, 6) Tamil Nadu Electricity Board Engineers' Sangam, 7) Tamil Nadu Electricity Board Thozhilalar Poriyalar Aykkiya Sangam & 8) Tamil Nadu Electricity Board Employees' Federation and with one Member each.

3) The duration of the function of the Apex Level Joint Committee and the Unit Level Joint Committee shall be for two years from the date of formation of the Committee.

4) The Chief Engineers/Superintending Engineers of the Regions/ Circles shall obtain the nominations from the said recognized Unions for the Employees' side for the Unit Level Joint Committee.

5) The Chief Engineers/Superintending Engineers shall take necessary action for the formation of Unit Level Joint Committee in their Regions/Circles, as ordered above. The fact of formation of Unit Level Joint Committee shall be informed to the Chief Engineer/ Personnel/Chennai without fail.
