ABSTRACT

MEDICAL AID – New Health Scheme, 2021 – Provision of Health Care Assistance to the Government servants and their eligible family Members through M/s. United India Insurance Company Limited Chennai – Extension of the validity of the Scheme for a further period of one year from 01.07.2025 to 30.06.2026 - Orders issued by the Government – Implementation in TNPDC – Orders – Issued.

PROCEEDINGS:-

The Government in its G.O. first read above, had issued orders, implementing New Health Insurance Scheme, 2021 to provide health care assistance for employees of Government Departments, State Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities etc. and their eligible family members with a provision to avail assistance up to the limit of Rupees Five lakhs in a block period of four years (from 1-7-2021 to 30-6-2025) as a CASHLESS model for the approved treatments/ surgeries (listed in the Annexure-I of the said order) in the network hospitals approved through the United India Insurance Company Limited which is a public sector company. However, the assistance shall be upto Rupees Ten Lakhs for the Specified illness listed in the Annexure-IA of the said order. The coverage of medical assistance shall be extended to accident cases where patient got approved treatment/undergone surgeries in a Non-network hospital.

2. The annual premium payable by the Government to the United India Insurance Company Limited shall be Rs.3,240/- (Plus Goods and Services Tax as per applicable from time to time) per employee, per annum for the block period of four years. The annual premium initially paid by the Government shall be recovered from the employee @ Rs.300/- per month (Rs.295/- -Subscription for NHIS + Rs.5/- contribution for corpus fund) by deduction in monthly salary. Based on the said Government Orders, Orders had been issued implementing NHIS 2021 to provide Health Insurance assistance to the employees of TANGEDCO (now TNPDC) for a block period of 4 years from 01.07.2021 to 30.06.2025.

3. The Government in its G.O. third read above, had issued orders, extending the NHIS' 2021 for employees for a further period of one year from 01.07.2025 to 30.06.2026 with assistance capped at Rs.5 lakhs for families of all insured employees and additional Rs.5.00 lakhs for specified illnesses as per the existing conditions of agreement made with M/s. UIIC Limited.

4. As the New Health Insurance Scheme' 2021 for the employees of TANGEDCO (now TNPDC) has been implemented based on the orders issued by the Government, a proposal for adoption of the orders issued by the Government in G.O. third read above extending the validity of the scheme for a further period of one year from 01.07.2025 to 30.06.2026, in TNPDC has been placed before the Board of TNPDC for its approval and after detailed examination, the Board has approved the same.

5. Accordingly it is hereby ordered that the NHIS 2021 for the employees of TNPDC. (erstwhile TANGEDCO) as implemented in Proceedings second read above, be extended for a period of another one year from 01.07.2025 to 30.06.2026, with assistance capped at Rs.5 Lakh for families of all insured employees and additional Rs.5.00 lakh for specified illnesses, as per existing terms and conditions.

6. All the Chief Engineers, Chief Financial Controllers, Chief Internal Audit Officer, Superintending Engineers and other Pay Drawing Officers may be instructed to communicate the above orders to their subordinates with regard to the implementation of NHIS 2021 and also to create awareness about the utilization of the Scheme and avail the benefits to the extent possible.
