PROCEEDINGS:-

In the reference first read above, Administrative approval was accorded to change the name of Coal Monitoring Division in the Electrical Maintenance-Coal Handling Plant Division (EM-CHP) in 3x210 MW NCTPS-I.

2. On scrutiny of the organization charts of NCTPS-I, NCTPS-II, TTPS, MTPS-I and II, it is observed that a separate Electrical Maintenance-Coal Handling Plant Division is available only in NCTPS-I. The Chairman-cum-Managing Director/ TANGEDCO has accorded approval for redeployment/ abolition/kept vacant of posts available in Electrical Maintenance-Coal Handling Plant Division/NCTPS-I.

3. Accordingly, the following non-workload posts in the 3x210 MW NCTPS-I Electrical Maintenance-Coal Handling Plant Division last continued in the reference second read above and the RWE posts sanctioned in the Electrical Maintenance-Coal Handling Plant Division are to be kept vacant and the said posts are to be used in other working areas in NCTPS-I :-

- i) Assistant Executive Engineer/Electrical - 3 Nos.
- ii) Assistant Engineer/Junior Engineer/Electrical - 12 Nos.
- iii) Junior Engineer/Electrical-II Grade - 1 No.

and one no. post of Executive Engineer/Electrical Electrical Maintenance-Coal Handling Plant Division is to be redeployed as Executive Engineer/Operation/ 400/ 230 KV GIS SS/Pulianthope.

4. The incumbent of the post sanctioned in para-3 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.
