In the proceedings 1st read above, among others orders have been issued for Streamlining the boundaries of the Madurai Distribution Region Comprising of Madurai EDC, Madurai EDC/Metro, Sivaganga EDC, Ramnad EDC and Theni EDC.

2) The Superintending Engineers/ Madurai EDC, Madurai EDC/Metro, Sivaganga EDC, Ramnad EDC and Theni EDC have submitted their proposal for streamlining the boundaries of the Madurai Region comprising of Madurai EDC, Madurai EDC/Metro, Sivaganga EDC, Ramnad EDC and Theni EDC is hereby approved.

3) Based on the approval of the Chairman-Cum-Managing Director/TANGEDCO, the following orders are issued.

- i) The boundaries in Madurai Circle be streamlined based on the District boundaries with DTs – 6,544 Nos., total No. of Service Connections – 7,17,179 Nos. (including HT) in City/Urban detailed in the Annexure-I.
- ii) The boundaries in Madurai Circle/Metro be streamlined based on the District boundaries with DTs – 5,676 Nos., total No. of Service Connections – 6,49,173 Nos. (Including HT) in City/Urban detailed in the Annexure-II.
- iii) The boundaries in Sivaganga Circle be streamlined based on the District boundaries with DTs – 4,647 Nos., total No. of Service Connections – 6,13,093 Nos. (Including HT) in City/Urban detailed in the Annexure-III.
- iv) The boundaries in Ramnad Circle be streamlined based on the District boundaries with DTs – 3,490 Nos. total No. of Service Connections – 5,11,676 Nos. (Including HT) in City/Urban detailed in the Annexure-IV.
- v) The boundaries in Theni Circle be streamlined based on the District boundaries with DTs – 5,719 Nos. total No. of Service Connections – 5,29,210 Nos. (Including HT) in City/Urban detailed in the Annexure-V.
- vi) After streamlining the above, five Electricity Distribution Circles with (Madurai EDC, Madurai EDC/Metro, Sivaganga EDC, Ramnad EDC and Theni EDC) the total No. of LT & HT Services – 30,20,331 Nos. and total No. of DTs – 26,076 Nos. are coming under Madurai Distribution Region as detailed in the Annexure-VI.
- vii) In respect of the additional/sections/posts sought for by the SE/ Madurai EDC/Metro action to be taken separately.
- viii) The above Divisions, Sub-Division, Sections and Sub-stations transferred to other Circle/Region (or) Received from other Region/Circle to Madurai Region along with Post/ incumbents.
