#### PROCEEDINGS:

In the proceedings 1<sup>st</sup> read above, among others orders have been issued for streamlining the boundaries of the Tirunelveli Distribution Region comprising of Tirunelveli EDC, Virudhunagar EDC, Tuticorin EDC and Kanyakumari Electricity Distribution Circles.

2) As per the above, the Superintending Engineer/ Tirunelveli EDC, Virudhunagar EDC, Tuticorin EDC and Kanyakumari EDC have submitted their proposals for streamlining the boundaries of the Tirunelveli Region comprising of Tirunelveli EDC, Virudhunagar EDC, Tuticorin EDC and Kanyakumari EDC and the proposals are hereby approved.

3) Based on the approval of the Chairman-Cum-Managing Director/TANGEDCO, the following orders are issued.

- The boundaries in Tirunelveli EDC be streamlined based on the District boundaries with DTs – 13,135 Nos., total No. of Service Connections – 13,87,611 Nos. (including HT) in City/ Urban as detailed in the Annexure-I.
- ii) The boundaries in Virudhunagar EDC be streamlined based on the District boundaries with DTs – 8,123 Nos., total No. of Service Connections – 8,98,880 Nos. (Including HT) in City/Urban as detailed in the Annexure-II.
- iii) The boundaries in Tuticorin EDC be streamlined based on the District boundaries with DTs – 6,380 Nos., total No. of Service Connections – 7,76,193 Nos. (Including HT) in City/Urban as detailed in the Annexure-III.
- iv) The boundaries in Kanyakumari EDC be streamlined based on the District boundaries with DTs – 7,813 Nos. total No. of Service Connections – 7,61,941 Nos. (Including HT) in City/Urban as detailed in the Annexure-IV.
- v) After streamlining the above four Electricity Distribution Circles, total No. of LT & HT Services – 38,24,625 Nos. and total No. of DTs – 35,451 Nos. are coming under Tirunelveli Distribution Region as detailed in the Annexure-V.
- vi) The above Divisions, Sub-Division, Sections and Sub-Stations transferred to other Circle/Region (or) Received from other Region/Circle to Tirunelveli Region along with the post is also approved.

4) It is also directed that, the Superintending Engineers/Tirunelveli EDC, Virudhunagar EDC, Tuticorin EDC and Kanyakumari EDC shall take necessary action to hand over/taken over the respective LT/LTCT/HT/ DTs as ordered in this proceedings immediately so as to streamline the boundaries of the Tirunelveli Region.
