Approval is hereby accorded for further continuance of 30 posts in Provincial and RWE cadre as furnished in the Annexure of this memo. for the period upto 29.02.2024 to the Office of the Chief Engineer (Distribution)/Chennai Region (PA code 2119).

- 2) It is also hereby ordered that the incumbents of the remaining posts over and above as last continued (except the 30 posts as allowed) shall be transferred to the nearby areas and the said posts shall be kept for redeployment. If any incumbents in the excess posts which could not be transferred to adjacent areas due to non-availability of vacancy, they may be **allowed to continue upto maximum of 6 months i.e., till 30.09.2024,** and thereafter the said posts may be redeployed. If the above said vacant posts couldn't be redeployed, **the post need not be filled up in future.**
- 3) The incumbent of the said posts shall be eligible to draw the Usual pay, Dearness allowance, House Rent Allowance, City Compensatory Allowance and other allowances, etc. at the rates as admissible under the orders in force wherever applicable.
