Establishment – TANGEDCO – Redesignation of the posts of Superintending Engineer/Chennai Development Circle-I and Superintending Engineer/Chennai Development Circle-II as Superintending Engineer/Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/ TANTRANSCO respectively – Change of control/ Reallocation of works/Re-distribution of Divisions/Sub-Divisions among Superintending Engineer/Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/TANTRANSCO – Orders – Issued.

PROCEEDINGS

The Chennai Development Circles namely Chennai Development Circle-I and Chennai Development Circle-II functioning under Chennai North and Chennai South Region respectively are looking after the activities of erection and commissioning of 33, 110 and 230 K.V. cables transmission network and 33, 110 and 230 K.V. indoor Sub-Station/G.I.S. Sub-Station and attending to their faults in Chennai Regions. Due to lack of field staff

and necessary tools and plants, 110 K.V/230 K.V. U.G. cables erection works are awarded under turnkey basis so far. The above two development circles are executing the transmission works as well as distribution works. After formation and functioning of TANTRANSCO and TANGEDCO companies under TNEB Ltd., it has been proposed to redesignate the posts of Superintending Engineer/Chennai Development Circle-I and Superintending Engineer/Chennai Development Circle-II as Superintending Engineer/ Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/TANTRANSCO respectively and to reallocate the works and to redistribute the Divisions/Sub-Divisions among the Superintending Engineer/Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/TANTRANSCO based on their portfolios of their companies for smooth operation and functioning of the Chennai Development Circles. The proposal has been approved by the Chairman-cum- Managing Director/TANGEDCO.

2. Accordingly, it is hereby ordered that the posts of Superintending Engineer/Chennai Development Circle-I and Superintending Engineer/Chennai Development Circle-II be redesignated as Superintending Engineer/Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/ TANTRANSCO respectively.

3. It is also hereby ordered that the post of Superintending Engineer/Chennai Development Circle-I now redesignated as Superintending Engineer/Chennai Development Circle/TANGEDCO shall remain under the control of the Chief Engineer/Distribution Chennai Region (North), Chennai and the post of Superintending Engineer/ Chennai Development Circle-II now redesignated as Superintending Engineer/ Chennai Development Circle/ TANTRANSCO hitherto under the control of Chief Engineer/Distribution/Chennai Region (South) shall be now placed under the control of the Chief Engineer/Transmission, Chennai as the cables and joints and other materials are procured and tendered by the transmission wing.

4. Consequent on the redesignation orders issued in para 2 above, the following reallocation of works are hereby ordered among Superintending Engineer/Chennai Development Circle/TANGEDCO and Superintending Engineer/Chennai Development Circle/ TANTRANSCO :-

Superintending Engineer/Chennai Development Circle/TANGEDCO

The Superintending Engineer/Chennai Development Circle/TANGEDCO shall look after the erection and commissioning of 33 K.V. cables transmission network and 33 K.V. indoor Sub-Stations and attending of their faults in both the Chennai Regions under TANGEDCO.

Superintending Engineer/Chennai Development Circle/ TANTRANSCO

The Superintending Engineer/Chennai Development Circle/ TANTRANSCO shall look after the erection and commissioning and attending faults of 110 K.V. and 230 K.V. cables transmission network and 110 K.V. and 230 K.V. indoor Sub-Stations/G.I.S. Sub-Stations in both the Chennai Regions under TANTRANSCO.

5. Consequent on the reallocation of works ordered in para 4 above, the Divisions and Sub-Divisions are redistributed among the respective Superintending Engineer/Chennai Development Circle/ TANGEDCO and Superintending Engineer/Chennai Development Circle/TANTRANSCO as detailed in the Annexure to this proceedings.

6. It is also ordered that the administrative control of Executive Engineer/G.I.S. hitherto under the control of Superintending Engineer/Chennai Development Circle-I shall be now placed under the control of Superintending Engineer-II/R-APDRP, Chennai

7. These orders shall take with immediate effect.

8. The receipt of this proceedings shall be acknowledged.




