PROCEEDINGS :

In the Board's Proceedings cited, orders were issued, fixing the ceiling limits on BSNL CUG Mobile phone call charges for various officers of the Board. It is also ordered therein that the ceiling limits should be reviewed after three months. In this connection, a Committee was constituted to review the ceiling limits of the Mobile phone call charges to various officers.

2. After reviewing the cases, the Committee has recommended the ceiling limit of the CUG Mobile call charges to the following officers with effect from January 2010 :-

Sl. No.	Category	Monthly Ceiling limit of Mobile phone charges under CUG scheme excluding rental charges and Service Tax. Rs.
1)	Assistant Engineers / Assistant Executive Engineers of Distribution Circles	200.00 per mensem
2)	Assistant Engineers / Assistant Executive Engineers of MRT, Special Maintenance and P&C only	100.00 per mensem

3. Accordingly, in continuation of the orders issued in Board's Proceedings cited, the ceiling limits on CUG of BSNL Mobile phones are fixed to the officers as mentioned in para-2 above with effect from January 2010.

4. The expenditure towards payment of Cell phone charges is chargeable to the Head of Account No. 76.111.

5. The receipt of the Board's Proceedings shall be acknowledged.
