# **PROCEEDINGS:**

Based on the orders of the Government, the Tamil Nadu Electricity Board in the Board's Proceedings first read above, had constituted a fund called "Tamil Nadu Electricity Board Pensioners' Health Fund" to provide financial assistance to pensioners for undergoing specialized treatment/surgery, if they are affected by major ailments. The approved list of the Special treatments/surgeries and a list of Private Hospitals accredited were annexed to the said order to provide assistance from the fund to the pensioners for undergoing treatment. Subsequently, Eye surgery/treatment was also included under the Tamil Nadu Electricity Board Pensioners' Health Fund Scheme.

- 2. In the Board's Proceedings second to fourth cited, orders were issued showing the list of diseases and the list of accredited private hospitals including certain additional diseases and Hospitals based on the orders of the Government.
- 3. In the Government Order fifth read above, the Government have now issued orders, relating to treatment/surgeries approved and relaxing certain stipulations under the Tamil Nadu Government Pensioners Health Fund Scheme but availed in unaccredited hospitals. The Board has examined and decided to adopt the said orders of the Government to the pensioners of Tamil Nadu Electricity Board.
- 4. Accordingly, it is hereby ordered that in partial modification of the orders in para 4 of the Board's Proceedings second read above that pensioners who undergo specialized advanced surgeries/treatments in respect of diseases which are included in the list approved under the Tamil Nadu Electricity Board Pensioners Health Fund Scheme in unaccredited hospitals shall also be eligible for the maximum grant of Rs.50,000/- (Rupees fifty thousand only) or 75% of the actual cost of such surgery/treatment whichever is less.

## PROCEEDINGS:

Based on the orders of the Government, the Tamil Nadu Electricity Board in the Board's Proceedings first read above, had constituted a fund called "Tamil Nadu Electricity Board Pensioners' Health Fund" to provide financial assistance to pensioners for undergoing specialized treatment/surgery, if they are affected by major allments. The approved list of the Special treatments/surgeries and a list of Private Hospitals accredited were annexed to the said order to provide assistance from the fund to the pensioners for undergoing treatment. Subsequently, Eye surgery/treatment was also included under the Tamil Nadu Electricity Board Pensioners' Health Fund Scheme.

- 2. In the Board's Proceedings second to fourth cited, orders were issued showing the list of diseases and the list of accredited private hospitals including certain additional diseases and Hospitals based on the orders of the Government. In the B.P. fifth read above, it was ordered that in partial modification of the orders in para 4 of the Board's Proceedings second read above, pensioners who undergo specialized advanced surgeries/treatments in respect of diseases which are included in the list approved under the Tamil Nadu Electricity Board Pensioners Health Fund Scheme in unaccredited hospitals shall also be eligible for the maximum grant of Rs.50,000/- (Rupees fifty thousand only) or 75% of the actual cost of such surgery/treatment whichever is less. But the above orders do not cover cases of treatment taken outside the State of Tamil Nadu.
- 3. In a specific case, a pensioner has represented for the refund of the claim to the eye surgery undergone in Aravind Eye Hospital/Pondicherry. The case was placed before the Board for a decision. While approving the above claim, the Board has resolved that in all such cases 50% of the cost of treatment may be paid subject to the ceiling.
- 4. In pursuance of the above decision, Tamil Nadu Electricity Board directs that the pensioners who have undergone treatment outside the State of Tamil Nadu shall also be eligible for sanction of financial assistance under the Tamil Nadu Electricity Board Pensioners Health Fund Scheme. It is also ordered that in all such cases 50% of the cost of treatment shall be paid as per the practice in vogue subject to the overall ceiling limit.

- There shall be no other change in the existing rules and conditions for sanction of assistance under the scheme.
  - 6. This order shall take immediate effect.
