PROCEEDINGS:-

Tamil Nadu Electricity Board has implemented 4 way CUG among Mobiles and existing Land Lines with effect from 1-9-2009. Consequent to the above and after careful review of expenditure incurred on account of Mobile charges, Board has approved the following revised monthly ceiling limits in respect of Mobile call charges for all the categories as given below:-

8)	Assistant Executive Engineers and Assistant Engineers of MRT, Special Maintenance, P&C.	Rs.100/-
9)	Assistant Executive Engineers and Assistant Engineers other than item No.7 and 8	Monthly rental of Rs.44 plus service tax
10)	VIP Drivers.	Rs.50/- plus monthly rental and service tax.

2) Accordingly in continuation to the orders cited under reference, the ceiling limits on Mobile phones are re-fixed as mentioned above.

3) The expenditure towards payment of Cell phone charges is chargeable to the Head of Account No. 76.111.

4) The ceiling limit fixed in para-1 above shall be strictly followed. Any excess expenditure in this regard shall be brought before the Chairman for approval.
