PENSION – Revision of pension – Payment of lump sum as one time payment pending implementation of the recommendation of the Official Committee – Orders – Issued.

PROCEEDINGS:

In the Government Order first cited, orders have been issued by the Government that an interim arrear amount at three months Pension + Dearness Pension + Dearness Allowance as on 1.1.2009 be sanctioned to all pensioners including family pensioners as on 1.1.2009, pending issue of Government Order based on the recommendations of the Official Committee. In the Government Order second cited, The Government have prescribed certain conditions for implementing the orders issued in the Government Order first cited. As the conditions prescribed therein have not been satisfied by the Board, the orders issued in the Government Order first cited could not be implemented by the Board.

2. All the Pensioners Associations have been representing for the adoption of the orders of the Government first cited and payment of interim arrear to the pensioners/family pensioners/Exgratia beneficiaries of Tamil Nadu Electricity Board. The said representations of the Associations have been considered by the Board.

3. The Board is following the orders of the Government and its executive orders issued from time to time in respect of pensioners of Tamil Nadu Electricity Board. Accordingly, revision of pension was ordered to the pensioners/family pensioners with effect from 1.1.1996 and the same is due from 1.1.2006. Considering the representations of the Pensioners' Associations and taking into account the due date for revision of pension, the Tamil Nadu Electricity Board direct that the pensioners/family pensioners/ Exgratia beneficiaries as on 1.1.2009 be paid a sum of Rs.4,000/- (Rupees four thousand only) being the consolidated lump sum amount as one time payment. The above said amount is adjustable against the benefit of the revision of pension due with effect from 1.1.2006 and fixation of pay in the revised scale of pay due from 1.12.2007.
