We appreciate and congratulate the efforts taken by the Election Commission to conduct a free and fair election in Tamil Nadu.

A tripartite settlement u/s 12(3) of the I.D.Act was entered on 18.11.2009 with trade unions of TNEB. Based on the above settlement, TNEB has issued B.P.No 223 dated 21.11.2009.

Clause (VIII) of the above B.P states the mode of payment of wage revision arrears as follows, ".. the balance arrears so arrived shall be paid in three equal installments as shown below:-

- (i) 1<sup>st</sup> installment in December 2009;
- (ii) 2<sup>nd</sup> installment in April 2010;
- (iii) 3<sup>rd</sup> installment in April 2011."

The payment of 3<sup>rd</sup> and final installment of the wage revision arrears is due to be paid before the end of this month.
