The settlement and the B.P. cited in the above references are related to the RWE employees and their promotions who are having station / circle seniority.

We have represented that, the Technical Assistants / Tester Chemicals who are under state seniority are to be excluded from the revision of the strength.

There is no reduction in the strength of Technical Assistants as per the Board's proposal on the proposed strength of RWE employees in all the four thermal stations. We have requested to make it clear in the settlement.

After negotiation our request was accepted and the settlement was entered with the trade unions which excludes the strength of Technical Assistants and Tester Chemicals.



Now the Chief Engineers of T.T.P.S. and M.T.P.S. are proposing to revise the strength of Technical Assistants based on the available strength and reducing their strength. Which is not correct and against the agreement.

2. Further it is also informed that Separate orders will be issued for allowing of Supernumerary Fitter Gr.II posts to the Selection Grade Helpers.
