PROCEEDINGS:-

In the reference first cited, orders have been issued to reward a Cash incentive of Rs.5,000/- each as a measure of motivation to all the employees/officers working in Audit Branch who are in service during the Accounting Year 2011-12, if the huge target of Rs.150.00 Crores collection is achieved by the Audit Branch for the year 2011-12.

2) The Audit Branch has achieved the target of collection of a sum of Rs.174.34 Crores through Audit findings as against the target of Rs.150.00 Crores for the year 2011-12 was apprised to the TANGEDCO and the same was approved by the Board.

3) Accordingly, it is hereby ordered for payment of Rs.5,000/- each as Cash incentive to all the employees/Officers working in Audit Branch who are in service during the Accounting Year 2011-12 as a measure of motivation. The employees who had worked in the Accounting Year 2011-12 partly but had retired or died subsequently shall be paid the Cash incentive proportionately as the case may be. The employees of Audit Branch who are on Extra-ordinary Leave without Pay and allowances, under Suspension and availing UEL on Private Affairs during the Accounting Year 2011-12 are not entitled for the Cash incentive for the above period.

4) The expenditure sanctioned in para-3 above shall be **debited to "TANGEDCO Funds – Revenue Expenditure – 75.763 Employees Cost – Cash Incentive for Internal Auditors"**.
