It has been proposed to call for applications from the qualified employees in Provincial and RWE categories, who possess the requisite qualification viz. B.Sc.(Computer Science), Bachelor of Computer Applications or Bachelor of Arts/Commerce/Science or any other equivalent Degree with Post Graduate Diploma in Computer Applications obtained from a University recognized by the University Grants Commissions; or Master of Computer Applications for appointment to the post of Assistant Programmer by Internal Selection.

2) Those willing employees who have passed the above said Degree, should submit their application in the prescribed format (Copy enclosed) to their head of office on or before 15.10.2010 and those who do not apply, with the prescribed time will not be considered for selection. Internal selection will be considered subject to the condition that the employees should have completed a minimum of two years regular service in the present post.
