#### **ANNEXURE-II**

## OTHER RECOMMENDATIONS PROPOSED BY THE WAGE REVISION COMMITTEE

- i. The Wage Revision Committee recommended to Create 306 posts and abolition of 457 posts in various categories in General Construction Circles.
- ii. The Wage Revision Committee recommended for abolition of Lineman equivalent posts in General Construction Circles and to create Line Inspector equivalent posts on par with the Distribution Circles and Thermal Power Stations where the Lineman posts have been abolished and they have been upgraded as Line Inspector earlier.
- iii. The Line Inspector equivalent posts in General Construction Circle will be commonly termed as "FOREMAN Gr.II" and Wireman equivalent posts will be termed as "FITTER".
- iv. Relaxation of educational qualification is considered as one time measure on par with Thermal Power Stations.
