**Sub : Establishment – TANGEDCO – Re-organization of Tamil Nadu Electricity Board – Change of technical control of transmission lines of 110 K. V. and 66 K. V. Sub-Stations and Chief Engineer/Protection and Communication, Chennai – Orders – Issued.**

**In Government Order first cited, orders have been issued reorganizing the Tamil Nadu Electricity Board as per the provisions of the Electricity Act, 2003.**

**2. In order to give effect to restructuring and for independent functioning of successor entities, it has been decided to change the technical control of all transmission lines of capacities 110 K.V. and 66 K.V. Sub-Station from Superintending Engineers/Electricity Distribution Circles to Superintending Engineers/Operation under TANTRANSCO wing.**

**3. Accordingly, it is hereby ordered that all the transmission lines of capacities 110 K.V. and 66 K.V. Sub-Stations hitherto under the technical control of their respective Superintending Engineers/Electricity Distribution Circles shall be now placed under the control of respective Superintending Engineers/Operation in addition to the 400 K.V. and 230 K.V. Sub-Stations under TANSTRANSCO Wing.**

**4. Consequent on the orders issued in para 3 above, the following are hereby ordered :-**

**i) TANGEDCO shall hand over the 110 K.V. and 66 K.V. Sub-Stations and depute the staff (both Provincial and R.W.E.) to TANTRANSCO as is where is basis.**

**ii) The status quo shall be maintained in respect of Administration and Accounts aspects of the Sub-Station (i.e) by Superintending Engineers/ Electricity Distribution Circles till such time the separate Administration and Finance Wing is framed and approved in the Office of the Superintending Engineer/Operation and Director/Operation.**

**iii) The status quo shall be maintained in respect of the works carried out by the GRT, MRT and Special Maintenance Wing. However, the Assistant Executive Engineer/MRT and Assistant Executive Engineer/Special Maintenance shall be under the technical control of Superintending Engineer/Operations in respect of 110 K.V. and 66 K.V. Sub-Stations.**

iv) The status quo shall be maintained in respect of sanctioning of technical estimates for the works in Sub-Stations (i.e) by Chief Engineers/Distribution and Superintending Engineers/Electricity Distribution Circle.

5. It is also hereby ordered that the Chief Engineer/Protection and Communication, Chennai shall also be placed under the technical control of Director/Operation, TANTRANSCO, Chennai.

6. These orders shall take with immediate effect.

7. The receipt of this memorandum shall be acknowledged.
