3) I request that the following clause may be incorporated in the appointment order to be issued to the employees:-

- i. that the employees shall produce a certificate of Physical Fitness obtained from a Medical Officer not lower in rank than that of a Civil Assistant Surgeon.
- ii. that the employees should join duty within 15 days from the date of relief from the post now held by him/them failing which it will be construed that he/they are not interested to accept the appointment and further action will be taken to cancel his/their appointment orders.
- iii. that the employees may be informed that no representation for change of posting or extension of time to join duty will be entertained.
- iv. that the employees concerned shall give an undertaking in writing to the effect that they will relinquish their rights for further promotion in the post now held by them.
- v. the employees who do not possess the adequate knowledge in Tamil should pass language test as per the rules.
- vi. that they should produce the following original certificate alongwith a Xerox copy in each for verification at the time of joining duty.
 - a) Evidence for date of birth (i.e. SSLC first page or Transfer Certificate)
 - b) Community Certificate.
 - c) Engineering Diploma Certificate awarded by State Board of Technical Education
