PROCEEDINGS

It has been represented that a section of graduate engineers in mechanical discipline who were appointed as Assistant Engineer/Mechanical in Tamil Nadu Electricity Board during the year 1979 to 1988 due to non-availability of posts of Executive Engineer/Mechanical for further promotion and working in the same post of Assistant Executive Engineer/Mechanical even after putting about 12 to 16 years. It is stated that there is no scope for them to get their second promotion as Executive Engineer/Mechanical before their retirement and requested to upgrade their posts as Executive Engineer/ Mechanical (Non-Independent) as was done in the case of Assistant Executive Engineer/Civil as Executive Engineer/Civil (Non-Independent) in order dated 11.07.08.

2. After careful consideration, it is hereby ordered that 48 posts of Assistant Executive Engineer/Mechanical in TANGEDCO be upgraded as Executive Engineer/Mechanical (Non-Independent) in the scale of pay of Rs.15,700-39,100 + Grade Pay Rs.7,000/- as a very special case, for a period of one year from the date of filling up of the upgraded post as Executive Engineer/Mechanical (Non-Independent), subject to the condition that no new Divisions shall be created to accommodate them, but they have to work wherever they are and do the work of Assistant Executive Engineer/Mechanical in their respective posts till they get promoted as Executive Engineers/ Mechanical in the regular vacancies, according to their seniority. The benefit of upgraded posts will be downgraded automatically at the time of the incumbents holding the upgraded posts get actual promotion in their turn or at the time when they get retirement or get relieved from the posts, whichever is earlier.

3. The upgradation ordered in para 2 above, shall include all those whose names were already included in the panel for promotion as Executive Engineer/Mechanical and awaiting their turn for promotion but

exclude all those who are on ex-ordinary leave as on date and disciplinary proceedings initiated against them. Accordingly, the 48 Selection Grade Assistant Executive Engineers/Mechanical listed in the Annexure are appointed as Executive Engineer/ Mechanical (Non-Independent) in the 48 upgraded posts.

4. It is also ordered that all the upgraded Executive Engineers/ Mechanical (Non-Independent) shall be given one increment with effect from their date of appointment as Executive Engineers/ Mechanical (Non-Independent).

5. The incumbent of the post ordered in para 2 above will be eligible to draw the usual Pay, Grade Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.

6. The expenditure is debitable to "Tamil Nadu Electricity Board Funds - Revenue - Expenses - 75 - Employees Costs - 75.1 - Salaries - 75.110 - Salaries Provincial".

7. The receipt of this proceedings shall be acknowledged.


