The promotions of Junior Engineer Gr II(Electrical) from Technical Assistants are pending for more than a year due to court cases which have been filed to safeguard the service regulations and the well settled procedures of the board in promoting the Junior Engineers Gr II under Diploma quota which is in strict practice for more than 25 years( since 1987).

The writ appeals filed by the Board and the Sangam are pending before the Hon'ble Chief Justice of Madras High court. Because of this inordinate delay in the hearing of the cases, the promotions of Junior Engineer Gr II(Electrical) from Technical Assistants under Diploma Quota are getting delayed.

Due to delay in filling up of vacant post of Junior Engineer Gr II (under diploma quota) more than 1400 post due for diploma engineers have got accumulated and the works of the Board are adversely affected apart from the mental agony being suffered by the Technical Assistants who are waiting for their promotion for the past one year after call for.



1. Order to issue promotions of the Diploma Holding Technical Assistants as Junior Engineer Gr II with a condition as done in 2012, i.e "the promotions are subject to the writ appeals pending before the Hon'ble High court".
2. Arrange to bring the case for hearing by making a special mention by the Advocate General / Additional Advocate General, who are appearing for the cases on behalf of the Board to the Hon'ble Chief Justice of Madras High Court for early redressal please.
