Sub: Assigning of CPF index number, Deduction of CPF subscriptions and issuing of annual account statement for the existing CPF account holders – Technical Assistants - represented - Reg.

T.N.E.B. has made it mandatory for all employees who are recruited on or after 01.04.2003 to become a member of CPF scheme, vide reference (1) & (2) cited above and consolidated instructions issued vide reference (3) cited above.

Accordingly:

- Each employee has to submit filled nomination form at the time of admission.
- Based on the nomination form CIAO will assign the index number.
- After assigning index number, recovery has to be made from the employees by the pay drawing officer / disbursing officer.


- Each employee will pay a monthly contribution of 10% basic pay (.P.B.+ G.P.) + DA and the management will pay matching contribution 10% (with 8% interest for both amounts).
- All new employees should be admitted to this scheme compulsorily and index number allotted promptly **within one month** from the date of joining in to the Board's service.
- Accounts slip shall be issued by the pay drawing officer / disbursing officer during April of succeeding each year.

We learn that, in many circles, for the Technical Assistants joined during the year 2009 the CPF recovery is not properly made and the account statement not issued. Also in many circles no action is taken to assign CPF index number and to deduct CPF contribution from the newly joined Technical Assistants (2014).

Hence, we request the Director / Finance and the Chief Internal Audit Officer to kindly instruct the officials concerned to;

- i) arrange for assigning CPF index number and commence recovery of CPF contribution from all directly recruited candidates (Technical Assistants) within one month as stipulated in the order.
- ii) issue annual account statement to the individuals every year promptly without delay.
