The Assistant Engineer / Internal Selection / Electrical panel was approved on 06.09.2012 and the respected Chairman cum Managing Director also cleared the note file in this issue.

T.N.E.B. Engineers' Association, after recruiting 450 Assistant Engineer / Electrical by Direct Recruitment during September 2012, in the back drop filed many cases against the Assistant Engineer / Internal Selection through outsiders challenging the Board's proceedings and policy.

We, the T.N.E.B. Engineers' Sangam in all the cases impleaded and dismissed the writ petitions cited in the reference (2) on 07.12.2012.

Similarly the personnel management in a biased manner rejected the eligible candidates from the Helper cum Meter Reader from the panel approved for the Assistant Engineer / Internal Selection / Electrical. Where in the same Helper cum Meter Reader and Mazdoors are included in the panel for the posts of Stores custodian Grade-II. etc.,

Against the rejection of their representation, the individuals have filed the writ petitions as cited in the reference (3). Sangam impleaded in the cases and the writ petitions were allowed on 07.12.2012 directing the Board to consider Helper cum Meter Readers for the post of Assistant Engineer / Internal Selection.

We are enclosing herewith the letter from our advocate in this regard.


We learn that, T.N.E.B. Engineers' Association is now filing fresh cases at Madurai High Court as they lost all the cases in Madras High Court.

As the seniority of the Assistant Engineer / Internal Selection and Direct Recruitment are to be fixed in the ratio of 1:1 in the particular calendar year, we request the Chairman cum Managing Director to kindly order to;

- i) release the appointment orders for 267 Assistant Engineer / Internal Selection / Electrical which was already approved on 06.09.2012.
- ii) approve the Assistant Engineer / Internal Selection / Electrical panel from the eligible candidates of the Helper cum Meter Reader with due seniority and release the appointment orders immediately.
