The orders issued subject to the outcome of ongoing cases and actual seniority would be arrived at separately once such cases after finality.

6. An option form for fixation of pay in the promoted post is enclosed herewith. The Officers are requested to return the option form duly filled in, within one month from the date of assumption of charge. If the option form is not received within the said period of one month, their pay in the higher post will be fixed as specified in para-3 of Board's Memo. No.75406/P1/90-1, dated 19.3.1991.
