ABSTRACT

Interim Monthly Payout/Interim Monthly Family Payout to eligible Government servants retired/ death-in-harness/death after retirement on or after 1.1.2026 – Dearness Relief on the interim payout – Amendment – Orders – Issued.

ORDER:

In the Government Order read above, interim monthly payout to the eligible Government servants covered under the Contributory Pension Scheme (CPS) who superannuate, or in the event of death-in-harness, on or after 01.01.2026 has been sanctioned by the Government. As per the said order, the interim monthly payout/Interim monthly family payout is to be computed at thirty percent (30%) of the monthly basic pay last drawn, or Rs.10,000/-, whichever is higher, plus 60% Dearness Relief thereon. The interim family payout in the event of death after superannuation has also been sanctioned in the said Government order.

2. In this connection, it has been brought to notice that eligible Government servants mentioned in the first paragraph had drawn last pay both under the Seventh and Sixth Pay Commission pay scales. The rate of Dearness Allowance admissible to Government servants who continue to draw, or who last drew, pay under the Sixth Pay Commission is 262% with effect from 01.01.2026.

3. The Government have examined the matter and, hereby direct that, in partial modification of/amendment to the relevant paragraphs of the Government Order read above, the Dearness Relief on the interim monthly payout/interim monthly family payout ordered in the Government Order cited shall be paid at the uniform rate of 60%, provided the 30% of monthly basic pay last drawn by the eligible

Government servant concerned under the Sixth Pay Commission is less than Rs.10,000/- and his pay is not refixed/claimed under the Seventh Pay Commission, it shall be stepped upto to the minimum Rs.10,000/- during the interim period, pending finalization of the main rules and procedure. If in case, the 30% of the monthly basic pay last drawn under the Sixth Pay Commission by the eligible Government servant is Rs.10,000/- and above, and his pay is not refixed/claimed under the Seventh Pay Commission, the Dearness Relief shall be sanctioned at the rate of 262% from the eligible date of interim monthly payout/interim monthly family payout. It is also reiterated that the Dearness Relief shall be calculated only at 60% of the monthly basic pay last drawn by the eligible Government servant under the Seventh Pay Commission.

4. The Commissioner of Treasuries and Accounts is directed to give suitable instructions to all the Pay and Accounts Officers/Treasuries in this regard for strict compliance.
