- (a) If the individual is involved in D.P/Vigilance Remarks and the work and conduct are not satisfactory, the transfer order need not be served to the individual and to send with the remarks in this regard to the Headquarters.
- (b) If the details furnished by the individual in the Request transfer application is found to be false, the transfer order need not be served to the individual and to send the remarks in this regard to the Headquarters.
- (c) If the individual has not completed one year service period in the present station, the transfer order need not be served.
